

TJB Publishing Terms and Conditions

1. The competitions are run by TJB Publishing Limited (THE COMPANY) also trading as www.school-events.co.uk
2. The competition is open to anyone in the United Kingdom and internationally around the globe, but must be a current full time student of a recognised school/nursery/organisation.
3. Entry can only be made via our website (www.school-events.co.uk) and with the express permission of an adult with authority over all entrants under the age of 18.
4. Entries must be made by the closing date as posted on our website.
5. How to enter the competition - Entries must be made via our website, which is available at www.school-events.co.uk.
6. The winning schools/nurseries/organisations will be announced via email and our website.
7. Unless you are under the age of 5, you agree to attempt the competition papers without academic help from any other third party body or books/internet
8. Only competitions that include prizes, will be included for the overall winner/s of the chosen competitions. We reserve the right to adjust the prize value and/or description of the physical award without notice.
9. Qualifying candidates to the competition are entitled up to 100% refund if a person is unwell/special circumstances and/or is unable to attend on the day of the competition. This needs to be accompanied by a legally recognised sick note or equivalent or at our discretion.
10. If winners cannot be contacted or do not claim prize/s within 14 days of notification, we reserve the right to withdraw the prize/s and pick a replacement winner/s. This only relates to competitions that offer a prize.
11. THE COMPANY will organise the prize delivery date. This only relates to competitions that offer a prize.
12. The competition and these terms and conditions will be governed by English and Welsh law and any disputes will be subject to the exclusive jurisdiction of the courts of England and Wales.
13. 15. If schools/tutors choose to provide pupil names for competition purposes to THE

COMPANY, then schools should arrange a method within their own organisation to do so.

16. Where a rebate amount or percentage of the competition entry fee has been agreed, the following terms apply: Schools and tutors will accept the rebate through their own payment systems. They are entitled to retain the agreed rebate portion from each candidate's fee, strictly in relation to competition entry only. This rebate structure also applies to purchases of both e-books and hard copy books, where applicable, under the terms of the promotional agreement. 24. In the event of THE COMPANY receiving fewer than 500 students/candidates pre paid student contestants/fees for any of THE COMPANY competitions, THE COMPANY has the right to cancel or reschedule the competition.
All schools/parents/guardians/Tutors/businesses agree by registering with us that they will refund all their students via their own schools/tutor/parents/guardians/business or similar school/business finance system at their own cost and at no charge/liability to THE COMPANY.

25. TJB Publishing Limited, known as School, reserves the right to amend competition dates or cancel competitions at its sole discretion. While every effort will be made to provide timely notice of any changes, we hold no responsibility for alterations or cancellations, whatever the reason, and are not liable for any resulting loss, inconvenience or disappointment even at unreceived/no notice for any reason.
26. In the unlikely event that there is a tie-breaking situation between one or more students in any of our competitions, Then each student will be judged on the bonus questions. Judges decisions are final.
27. In addition THE COMPANY reserves the right to cancel/reschedule for any other reasons whatsoever including staff absence.
All registered schools/tutors/parents/guardians/businesses agree to refund/notify all students at their own cost and at no cost/liability to THE COMPANY. Should any issues result in permanent cancellation for any reason THE COMPANY are not held financially liable or in any other way responsible for cost/time in refunding students. 28. All completed competition online papers must be submitted back to THE COMPANY via an email account belonging to either a school, parent or guardian. Return of papers under no circumstances should be from a student's personal email account even if the student is aged 18 or over. THE COMPANY will not be held responsible/liable in any way if students do not follow all competition rules set by THE COMPANY.
